Eligibility & Mechanics

1. Applications are open to sporting and community groups/organisations who conduct a regular sporting activity that promotes and encourages a healthy lifestyle and whom are residents of Australia and located in Far North Queensland.
2. Applicants aged under 18 years of age must obtain the consent and authority of persons aged 18 years and over that are authorised representative/s of the sporting or community group/organisation that they are applying on behalf of. Applicants who are under the age of 18 years and submit an application without disclosing (or who attempt to conceal) their age (as and where required) and/or do not provide the required consent (as and where required) will be deemed invalid.
3. Eligible applicants are required to provide a response to all questions on the grant application or the application will be deemed invalid.
4. Multiple entries are permitted, however each entry must be submitted separately and must comply with the Terms and Conditions of the Application. Application submitted by post must be an original and photocopies or images of grant applications will not be accepted. Incomplete, offensive, inaccurate, illegible or incomprehensible submissions will be deemed invalid. Internet submissions will be deemed to be accepted at the time of receipt and not at the time of transmission. The Club accepts no liability for late or loss of misdirected submissions. The decision to accept or reject an application will be at the sole discretion of The Club.

5. An eligible sporting or community group is a registered and/or verifiable local sporting or community organisation that benefits and contributes to the local community for public good e.g. school, sporting, not-for-profit or charitable groups. It does not include professional sporting, political, or other groups which The Club may determine, at its sole discretion, are involved in the conduct of activities that may offend prevailing sporting or community standards. The Club at all times and in its sole discretion, may determine the eligibility of a sporting or community group with regards to the nature of the activities, the structure and any other considerations determined by The Club.
6. The successful applicants will be chosen by a five (5) person judging panel represented by a combination of The Club's Senior Management and its Board of Directors.
7. The maximum grant issued to a single organisation will be determined by the judges.
8. The Judging Panel's decision is final and no correspondence will be entered into.
9. The successful applicants will be announced in The Cairns Post and online at **www.brotherscairns.com.au** on Thursday 13 October 2011 and may be provided with a "Sportscene" Grant Authority Form at the "Brothers Community Sport Development Program" Presentation Night held at 7pm on Tuesday 25 October 2011 at Brothers Leagues Club, 99-105 Anderson Street, Manunda, Cairns, QLD. Alternative arrangements will be made for those successful applicants to collect their grant subject to prior approval from The Club.
10. All applications must be received prior to 5pm on 30 September 2011 and not before 9am on 1 September 2011. Applications received outside this period will not be accepted.
11. Successful applicants may be required to provide a summarised written report outlining how the money was spent and how this expenditure has assisted them.
12. Applicants that do not lodge their Grant Authority Form with "Sportscene" by Saturday 26th November 2011 will forfeit their grant in the 2011 round. No extensions will be granted, however applicants will be allowed to re-apply in future rounds.

General Terms and Conditions

- The Club accepts no liability for any variation in the grant value. The Club will not be responsible should the gift card or proceeds from the successful grant application become unavailable for reasons beyond The Club's control. Any material/aides or applications used by the Judging Panel will be securely retained at the sole discretion of the club.
- The Club reserves the right to request an applicant to produce appropriate photo identification or any other documentation (to the club's satisfaction at its sole discretion) in order to confirm the applicant's identity, age, residential address and email address, eligibility to enter the Program and any information submitted by the applicant in entering the program (including, where a winner is under 18 years of age, or representative that gave their consent) before issuing a gift certificate. If the documentation required by The Club is not received by The Club (or its nominated agent) or the applicant's eligibility has not been verified or validated to The Club's satisfaction within the time requested, the entry will be deemed invalid. A gift certificate will only be awarded following any successful applicants validation and verification that The Club requires in its sole discretion.
- The Club reserves the right to verify the validity of submissions and reserves the right to disqualify any applicant for: a) tampering with the entry process; or b) for submitting an entry which is not in accordance with these Terms and Conditions of Entry; or c) if the applicant is engaged in any unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of the program.
