ELIGIBILITY

MECHANICS

Get tickets with every \$5 Spend at the bar/ bottleshop, and Restaurant. And with any \$10 Pokie Win. Tickets are automatically dispensed from the ticket spitter when your Membership card is used throughout the club from 6pm till 9pm on the day of the draws.
